## NOTICE TO EXHIBITORS

- **The safety of the dogs is the primary concern so by entering this trial, exhibitors acknowledge that they are familiar with the rules and regulations of this sport, and that their dogs are familiar with and able to perform all obstacles safely.**
- **Entry fees will not be refunded in the event that a dog is absent, disqualified, excused, or barred from competition by action of the Trial Committee.**
- **It is expressly understood that exhibitors alone are responsible for the behavior of their dog(s) and/or children. Any exhibitor whose dog(s) and/or children create unnecessary disturbances or repeatedly engage in unsafe or disruptive behavior may at the discretion of the Trial Committee, be asked to leave the trial site. If an exhibitor is asked to leave the trial site, then the exhibitor will not be refunded any fees that have been paid.**
- **Entry fees will not be refunded if the trial cannot open or be completed by reason of riots, civil disturbances, fire, an act of God, public emergency, act of a public enemy, or any other cause beyond the control of the organizing committee.**
- **Exhibitors are responsible for complete, accurate, and legible information on the entry forms. Any illegible or incomplete entries will not be entered in the trial.**

### **Special note to handlers participating in the Silkenfest:**

We realize that there are multiple Silken Windhound national specialty events occurring on Wednesday. Any Silken Windhounds also participating in the FastDASH specialty event at Zoiboyz will be allowed to run FastDASH upon arrival at that site. It is approximately 20-25 minutes between the agility and the FastDASH locations. We cannot hold the agility ring if you are not present for your runs.
